EVENT INFORMATION: Event hours are 3:30p.m. – 9:30p.m. Friday, July 4th, 2025 at Vidinha Soccer Field.

CRAFT VENDOR SPACE: Craft Vendor Booth fee is \$250.00 per regular booth space. Corner spaces are \$275.00 per booth space. Due to limited corner spaces, applicants interested in securing a corner space are required to submit their application with payment in person at the Kauai Hospice Office. Covered booths are approximately 8x8 with one 8 ft. table provided. Vendors must limit their products and displays to their assigned space. Please be considerate of your neighbors.

FEES: Booth fees must be paid with the application. Applications will be confirmed upon receipt of a complete application and full payment of fees. A Kaua'i Hospice Representative will contact you within (3) business days of receiving your complete application and payment to confirm your space at the Event. **Receipt of payment by Kaua'i Hospice, does not confirm space.** Applications and all fees must be received and paid by June 1, 2025. Failure to pay in full and submit all required information by June 1, 2025 will exclude the Applicant from the event. Applicant fees are non-refundable except for those vendors whose applications are not accepted. A copy of a valid Hawaii State Business License must be submitted with your application and fees.

ENTRY & EXIT: Booth set up begins at 10:00a.m. Friday, July 4th, NO EARLIER. Drive onto the soccer field and park your vehicle. Walk to the Craft Vendor Tent and check-in with the Coordinator to receive your assigned booth location & parking pass. Each Applicant/Vendor Booth space will be allowed FREE entrance for (3) three individuals (this includes the applicant) to the Event. The applicant will be given (3) three wristbands for FREE entrance and (1) one parking pass for the reserved parking lot at July 4th event upon check-in at the Craft Vendor Booth tent during set-up on July 4th from 10:00a.m. - 1:00p.m. NO EXCEPTIONS. Upon receiving your assigned booth space you may move your vehicle near your space to off-load your merchandise, then immediately move your vehicle off the field to the Reserved Stadium Parking Lot. ALL vehicles must be removed from the soccer field to the paved parking lot by 1:00p.m. NO EXCEPTIONS. Booth must be broken down by 11:59p.m. on July 4th.

GENERAL TERMS & CONDITIONS: Booth assignments are at the complete discretion of Kaua'i Hospice, Inc (herein KH). Preference will be given to vendors that: 1) are certified Kauai Made Vendors 2) offer hand-made products and 3) uniqueness of products. All food products must be in sealed and labeled packaging. Registrant vehicles will not be allowed into the park event area after 1:00p.m. on Friday, July 4, 2025. Kaua'i Hospice, it's officers, agents and sponsors are not responsible for any product or property left overnight. Registrant must remain open during the entirety of event hours. No early break downs. Registrants and their agents are expected to conduct themselves in a professional manner, abide by the rules of the festival and exhibit the spirit of aloha. The Kaua'i Hospice, 4th of July Concert in the Sky is a Drug, Tobacco and Alcohol-Free event. Consumption of illegal drugs, alcohol or tobacco at the event is strictly prohibited. All food vendors must provide a copy of their certification from the State Department of Health to KH and display it at their booths. KH, its directors, or agents has the right to determine what goods or services may be sold by a Registrant, without liability to its directors, agents or sponsors. KH, its directors, or agents has the right to exclude a Registrant from participation in the Event, for any reason, without liability to its directors, agents or sponsors. Registrant in consideration of participation in the 4th of July Concert in the Sky sponsored by KH, individually, jointly and in any representative or legal capacity, on behalf of Registrant, Registrant's heirs, executors, and/or administrators, does hereby waive, release, discharge and agree to hold harmless and indemnify Kaua'i Hospice, Inc., its officers, agents and sponsors from liability or loss of any claim for death, injury, or damage to property resulting directly or indirectly from the Registrants participation in the Event.
